
This re delegation is subject to the following:

**Delegation of Authority--Liability Statement, Transportation Research Board/National Research Council**

At the November 17, 1995 meeting, The Regents granted the President blanket authorization to execute a Transportation Research Board/National Research Council (TRB/NRC) Liability Statement which requires assumption by the University of third-party liability, action which is restricted to The Regents under Standing Order 100.4(dd)(9).
