Delegation of Authority–Execution of Agreements

In a letter dated December 30, 1991 ([DA1058](#)), the President delegated to Chancellors the authority to execute various service agreements required with outside organizations, agencies, and individuals to implement approved programs and activities, whether the University is the supplier or recipient of the service covered by the agreement. Within the scope of this delegation, the Chancellor is authorized to negotiate and execute all such agreements except those which contain provisions falling within the restrictions and limitations set forth in [Standing Order 100.4\(dd\)](#), or require approval of The Regents because of specific Regental policy, or require approval by the President pursuant to specific memoranda issued from time to time. This re-delegation supersedes all previous re-delegations related to DA1058.

This re-delegation is not to be used for the following transactions, which are covered under the noted re-delegations:

- Execution of purchase contracts, sub-contracts, and standards purchase orders for goods and services to be supplied to the University ([DA2100](#));
- Real property rental agreements ([DA2629](#));
- Solicitation and acceptance of execution of certain extramural grants and contracts ([DA2569](#));
- Affiliation agreements with other institutions or hospitals ([DA0916](#));
- Solicitation or acceptance of gifts ([DA2631](#)); or
- Those delegations established in Business and Finance Bulletins, such as [BUS 43: Purchases of Goods and Services, Supply Chain Management](#), or in University

policies, such as the [University of California Patent Policy](#) or [University of California Policy on Copyright Ownership](#).

In addition, the re-delegations conveyed here are not to be used for foreign exchange and linkage agreements or for creating foreign affiliation agreements or memoranda of understanding.

Various Service Agreements Required with Outside Organizations, Agencies, and Individuals

In the letter noted above, the President delegated to each Chancellor the authority to execute various service agreements required with outside organizations, agencies, and individuals to implement approved programs and activities (e.g. revenue generating activities such as testing/analytics, sponsorships, short-term facility rentals and performance agreements not covered by delegations below). In accordance with the parameters detailed in that letter, I hereby re-delegate this broad authority to the following provided that all agreements under these re-delegation authorities must be executed in accordance with the applicable University policies and procedures governing the particular transaction, including, but not limited to, Business and Finance Bulletins:

- **Vice Chancellor, Finance and Administration & Chief Financial Officer**
- **Vice Chancellor, Research, Innovation & Economic Development**

Additionally, specific and limited re-delegations for service agreements required with outside organizations, agencies, and individuals to implement approved programs and activities are provided as follows:

- All agreements under these re-delegation authorities must be executed in accordance with the applicable University policies and procedures governing the particular transaction, including, but not limited to, Business and Finance Bulletins.
- **Each agreement must be approved as to legal form by Legal Counsel prior to execution unless it is in a form previously approved by that office within the last two years and is issued without revision.**

1. Agreements for Concerts, Lectures, Rental of Films, and Various Theatrical or Musical Productions

In accordance with the letter noted above, I hereby re-delegate the authority as follows:

- **Dean, College of Humanities, Arts & Social Sciences** – authority to execute agreements for concerts, lectures, rental of films, and various theatrical or musical productions within your area of responsibility.
- **Vice Chancellor, Development and Alumni Engagement**– authority to execute agreements for concerts, lectures, rental of films, and various theatrical or musical productions within your area of responsibility.

- **Vice Chancellor, Student Affairs** – authority to execute agreements for concerts, lectures, rental of films, and various theatrical or musical productions within your area of responsibility.

2. Agreements with California Schools and/or School Districts for Teacher Training Programs

In accordance with the letter noted above, I hereby re-delegate the authority as follows:

- **Dean, School of Education** – authority to execute agreements with California schools and/or school districts for teacher training programs.

3. Agreements with Outside Agencies Covering the Use of Facilities and Instructors for Regular University Courses

In accordance with the letter noted above, I hereby re-delegate the authority as follows:

- **Dean, University Extension** – authority to execute standard Facilities Use Agreements pertaining to the rental of classroom or conference room space within UCR Extension Center. Requests for exceptions to the standard Facilities Use Agreements are to be coordinated with the campus Risk Coordinator prior to making any commitments.

4. Agreements with Nonprofit Agencies for Employment of Students under the Work-Study Program

In accordance with the letter noted above, I hereby re-delegate the authority as follows:

- **Associate Vice Chancellor, Enrollment Services** – authority to execute agreements with nonprofit agencies for employment of students under the Work-Study Program.

5. Intercollegiate Athletic Agreements (Except Coaching Contracts)

In accordance with the letter noted above, I hereby re-delegate the authority as follows:

- **Director, Intercollegiate Athletics** – authority to negotiate and execute various agreements required for intercollegiate athletic events (except coaching contracts), which includes normal service-type contracts, e.g. game contracts, and concessions.

6. Chief Executive Officer, UCR Health

In accordance with the letter noted above, I hereby re-delegate the authority as follows:

- **Chief Executive Officer, UCR Health** – authority to negotiate and execute payor contracts and other agreements for payments to be made to UCR for

providing clinical services, whether directly with a payor (such as insurance program) or with a third party or intermediary.

Again, these re-delegations supersede all previous delegations on the subject under DA1058.
